Official Rules and Regulations

1. Eligibility

The \$100 Gift Card Survey Giveaway (the "Sweepstakes") is open to legal residents of Mesa County, Colorado who are 18 years of age or older at the time of entry. Employees of The Grand Junction Area Chamber of Commerce ("Sponsor") and their immediate family members are not eligible to participate. 2. Sponsor

The potential winner will be selected in a random drawing conducted by the Sponsor on or about September 5, 2024, from all eligible entries received during the Sweepstakes Period. The odds of winning depend on the number of eligible entries received. The potential winner will be notified by email or phone within five (5) business days following the drawing. If the potential winner cannot be contacted, is ineligible, fails to claim the Prize within seven (7) days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the Prize may be forfeited and an alternate winner selected.

8. Taxes
